

SSGKC is positioned as a unique, vibrant and sustainable city that is highly attractive to both talents and knowledge-based industries. In the next 20 years, SSGKC, covering an area of 123 square kilometers, is expected to house a live-in population of 500,000 and will provide a harmonious "live, work, learn and play" environment.

Investment incentives for Advanced Manufacturino

● 项目落户奖 Investment Award

对符合条件的新设立内外资企业,按照实缴注册资本金,一次性给予企业500万-1000万元奖励。

Local government will offer one-off incentive to eligible enterprises, regardless of domestic or foreign-funded enterprises. The incentive is about 5-10 mil yuan for enterprises according their paid registered capital.

◆ 经营贡献奖 Business Contribution Awards

当年营业收入10亿元以上或本区地方经济发展贡献前50强的企业,按照其当年对本区地方经济发展贡献的15%予以奖励,最高不超过5000万元。

For those enterprises with annual revenue more than 1 billion yuan or the top 50 enterprises for tax contribution in GDD, they can be rewarded in accordance with 15% of their tax contribution for GDD, with the maximum amount of 50 million yuan.

夢 高管人才奖励 Senior Management Talent Awards

符合条件的企业,其高级管理人员按照个人应纳税所得额的10%予以奖励,每人每年最高不超过300万元。

For qualified enterprises, the senior management personnel can be rewarded in accordance with 10% of the personal tax, up to a maximum of 3 million yuan per person per year.

◆ 转型升级奖励 Transformation and Upgrade Awards

鼓励企业增资扩产,扩建自用生产、仓储场所5000平方米以上的,按每平方米40元的标准给予一次性奖励,每家企业最高奖励200万元。

Encourage enterprises to increase their investment expansion, expanding production space for own use, or storage area to more than 5,000 sqm, then 40 yuan per sqm will be given as an one-off award, the highest award of each enterprise is 2 million yuan.

● 产业联动发展奖励 Industry Common Development Incentives

对区内企业购买区内企业生产的产品和服务,当年达到1000万元以上且营业收入同比正增长的,给予买方企业当年购买总额的2%补贴,全年最高不超过200万元。购买区内企业生产的机器人整机或成套机器人生产设备,当年达到200万元以上且营业收入同比正增长的,给予买方企业当年购买总额的5%补贴,全年补贴最高不超过200万元。

Encourage enterprises to purchase products and services of local enterprises in GDD. If the buyer's annual revenue is over 10 mil yuan with positive annual growth, the buyer can get a subsidy for 2% of the total purchase amount, up to 2 mil yuan.

Encourage the enterprises to purchase robots or sets of productive system. If the buyer's annual revenue is over 2 mil yuan with positive annual growth, the buyer can get a subsidy for 5% of the total purchase amount, up to 2 mil yuan.

适用范围:

适用于工商注册地、税务征管关系及统计关系在黄埔区、广州开发区,有健全的财务制度、具有独立法人资格、实行独立核算。

Apply to local enterprises or new enterprises transferred into GDD, with business and taxations registered in GDD. In addition, these enterprises must be the independent legal entity and conduct business accounting independently.

Investment Incentives for Modern Service Industry

● 项目落户奖 Investment Award

对符合条件的新设立内外资企业、按照实缴注册资本金、一次性给予企业500万-1000万元奖励。

Local government will offer one-off award of 5-10 mil yuan to eligible enterprises, according their paid registered capital, regardless of domestic or foreign enterprises.

◆ 经营贡献奖 Business Contribution Awards

对达到经济效益指标的商贸业企业,按照当年对本区地方经济发展贡献的40%予以奖励。对达到经济效益指标的其它营利性服务业企业,按照当年对本区地方经济发展贡献的50%予以奖励。

对本办法实施后2017年内新注册的企业,当年统计达到规模以上或本区地方经济发展贡献达到100万元以上的,从2017年起连续3年按照对本区地方经济发展贡献的100%予以奖励(含高级管理人员享受的奖励)。

For those enterprises within trading and service sector that achieved the operation & profit target of GDD, can get awards by 40% of their tax contribution during that year. For those modern service enterprises exclude trading sectors that achieved the operation & profit target of GDD, can get awards by 50% of their tax contribution during that year. For the new registered enterprises in 2017, with the tax contribution over 1 mil yuan, can get awards by 100% of their tax contribution for 3 years.

高管人才奖励 Senior Management Talent Awards

符合规定的企业,其高级管理人员按照个人应纳税所得额的10%予以奖励,每人每年最高不超过300万元。

For those qualified enterprises, the senior management personnel will be rewarded by 10% of their income tax, up to 3 mil yuan each person.

◆ 产业联动发展奖励 Industry Common Development Incentives

服务于本区现代服务业,依法注册成立并按章程开展活动的行业协会,经认定给予每年30万元活动经费补贴。 对经国家、省、市商务部门认定的电子商务示范企业或园区,分别按照100万元、50万元、20万元的标准给予一次性奖励。

The industry association legally incorporated and organized in GDD, will be rewarded 0.3 mil yuan as they can offer services for local modern service industry. For the E-commerce Park identified by the state, provincial and municipal level, will get one-off rewards by 1 mil yuan, 0.5 mil yuan, 0.2 mil yuan respectively.

企业上市奖励 Awards for Listed Enterprises In Stock Market

对在境内外资本市场上市企业给予300万元奖励,对成功在"新三板"挂牌的企业给予100万元的奖励.

Local government will give rewards of 3 mil yuan for listed enterprises in domestic and oversea Stock Market, and 1 mil yuan for listed enterprises on new three boards.

适用范围:

适用于工商注册地、税务征管关系及统计关系在黄埔区、广州开发区、有健全的财务制度、具有独立法人资格、实行独立核算。

Apply to local enterprises or new enterprises transferred into GDD, with business and taxations registered in GDD. In addition, these enterprises must be the independent legal entity and conduct business accounting independently.

nvestment Incentives for Headquarters Economy

● 项目落户奖 Investment Award

对符合条件的新设立内外资企业、按照实缴注册资本金、一次性给予企业600万-1500万元奖励。

Local government will offer one-off award of 6-15 mil yuan to eligible enterprise, according their paid registered capital, regardless of domestic or foreign enterprises.

◆ 经营贡献奖 Business Contribution Awards

对当年营业收入达到5亿元以上且同比正增长的企业、按照其当年对本区地方经济发展贡献的60%予以奖励。

对本办法实施后2017年内新注册的企业,从2017年起连续3年按照对本区地方经济发展贡献的100%予以奖励(含高级管理人员享受的奖励)。

For those enterprises that achieved annual revenue of 500 mil yuan with positive annual growth, can get awards by 60% of their tax contribution. Besides, for new registered enterprises in 2017, can get awards by 100% of their tax contribution for 3 years.

高管人才奖励 Senior Management Talent Awards

符合规定的企业,其高级管理人员按照个人应纳税所得额的10%予以奖励,每人每年最高不超过300万元。

For those qualified enterprises, the senior management personnel will be rewarded by 10% of their income tax, up to 3 mil yuan each person.

◆ 办公用房补贴 The Office Subsidies

符合条件的总部企业租用办公用房且自用的,按每月每平方米50元的标准予以场地补贴,期限3年,每年最高补贴金额不超过300万元,购置办公用房且自用的,按购买房价的10%一次性给予补贴,最高不超过500万元。

For the qualified headquarter enterprisesss that lease the office for their own use, can get the subsidies of 50 yuan per sqm per month, for 3 years, up to RMB 3 mil each year.

企业上市奖励 Awards for Listed Enterprises In Stock Market

对在境内外资本市场上市企业给予300万元奖励,对成功在"新三板"挂牌的企业给予100万元的奖励.

Local government will give rewards of 3 mil yuan for listed enterprises in domestic and oversea stock market, and 1 mil yuan for listed enterprises on New Three Boards.

适用范围:

本办法所指的总部企业应同时满足下列条件。本区范围内,有健全的财务制度、具备独立的法人资格、实行独立核算。截至上一年度,全资或绝对控股公司、分公司不少于3家,其中区外公司不少于2家;

年度对本区地方经济发展贡献不少于1000万元,注册资本3000万元以上或年度净资产6000万元以上或年营业收入5亿元以上。

Enterprises must be the independent legal entity, and conduct business accounting independently; Wholly holding 3 subsidiaries or branches. The annual business contribution to the local district is less than 10 mil yuan; The registered capital reach 30mil yuan or annual net assets reach 60mil yuan, or annual operation revenue reach 500 mil yuan;

Investment Incentives for High Sci&Tch Industry

● 直接股权投资扶持 Direct Equity Investment Support

对符合条件的高层次人才创办的高科技企业,以直接股权投资的方式最高给予3000万元、占股比例不超过20%、年限不超过10年的扶持。

Qualified high-tech enterprises founded by high-level talent can get direct equity investment, up to 30 million yuan, with no more than 20% shares, investment time is no more than 10 years.

拳 国家高新技术企业落户奖励 State-Certificated High-tech Enterprises Investment Awards

经国家认定且在有效期内的高新技术企业新落户本区的,在享受市有关政策的基础上,每家再给予40万元落户奖励;落户三年内纳入本区规模以上企业统计且在高新技术企业有效期内的,再给予10万元奖励。

For the state-level high-tech enterprises registered in GDD, can get extra rewards of 400,000 yuan besides the municipal rewards. Furthermore, when the enterprise can be counted into the scaled enterprises of GDD after its registration within 3 years, the enterprise can gets another reward of 100,000 yuan.

◆ 科技项目配套 Sci-Tch Support

对获得国家、省、市立项资助的各类科技项目(含知识产权项目)及科技奖励予以配套,分别按照资助金额的100%、70%、50%给予资金配套支持,最高分别不超过500万元、300万元、100万元。

Local government will provide financial support to various scientific and technological projects(IP projects included) that have been enclosed by Chinese central government, Guangdong provincial government and Guangzhou municipal government. For the state-level project, local government will offer 100% financial support, up to 5 mil yuan. For the provincial-level project, local government will offer 70% financial support, up to 3 mil yuan. For the municipal-level scientific and technological project, local government will offer 50% financial support, up to 1 mil yuan.

◆ 研发机构奖励 Funding Support to Institutes

对经国家部门单独或联合认定的国家工程技术研究中心、国家工程研究中心、国家工程实验室、产业创新中心等研发机构,采用后补助的 方式给予300万元资助.

For state-level engineering technology research center, engineering research center, engineering lab, industry innovation center, will gets 3 mil yuan subsidies after event.

◆ 金融扶持 Financial support

对投资区内人才创新创业项目的创业投资基金,按项目给予累计投资金额5%的奖励,对同一项目投资给予的奖励不超过100万元,对一家创业投资基金每年的奖励金额不超过200万元。因投资失败产生投资亏损的,给予投资亏损额30%的补偿,单个项目补偿金额不超过200万元。

For the investment funds who invest the Innovation and Entrepreneurship, there has the rewards by 5% of the accumulated amount of the investment, up to a maximum of RMB 1 mil. And the highest awards for one Investment fund each year would be no more than RMB 2 mil. If the investment failed, the funds would be subsidized by 30% of the deficit, with each project up to RMB 2 mil.

适用范围:

适用于工商注册地、税务征管关系及统计关系在黄埔区、广州开发区,有健全的财务制度、具有独立法人资格、实行独立核算。

Apply to local enterprises or new enterprises transferred into GDD, with business and taxations registered in GDD. In addition, these enterprises must be the independent legal entity and conduct business accounting independently.

鼓励引进重点产业项目办法

The measures to encourage the settlement of preferential industrial projects

奖励范围 Scope for the incentive

除特别规定外,自公布之日起在本区内新设立或迁入,在本区办理工商和税务注册登记,纳入本区统计口径,有健全财务制度、具有独立法人资格、实行独立核算的企业或机构(房地产项目公司除外)。须承诺自获得奖励起10年内注册及办公地址不迁离本区,不改变在本区纳税义务,不减少注册资本。

Local enterprises (except for property developers with property-only projects, but property developers with headquarters located in GDD are eligible) with industrial & commercial formalities and taxation registered locally in Guangzhou Development District (GDD) or business parks under its supervision, that operate in compliance with legal requirements and pay tax accordingly, are able to access these favorable policies; in addition, these enterprises must have an independent legal person status and conduct business accounting independently. Plus, these enterprises must agree not to move out of GDD within the next 10 years upon receiving this special incentive, and try no attempt in reducing its registered capital or make changes to its tax contribution.

🦫 项目落户奖 Project landing award

对符合奖励条件的内外资企业,分别按三年内实缴注册资本金,一次性给予企业300-800万奖励,增资或新迁入企业可按新增实缴注册资本金申请奖励。

Local government will offer one-off incentive to eligible enterprises, regardless of domestic companies or foreign-funded companies, as long as these enterprises comply in paying their registered capital in full in three years. The incentive is about 3 to 8 million yuan for each enterprise; newly moved-in enterprises or enterprises with added registered capital can apply for additional incentive.

● 经营贡献奖 Business operation award

- (1) 根据企业对本区的贡献程度,按企业营业收入的一定比例给予奖励,对贡献特别重大的企业另行予以重奖。
- (2) 鼓励引进战略性新兴产业和科技含量高、成长潜力大的重大项目、并给予重奖。鼓励企业进驻中新广州知识城、并优先给予奖励。
- (1) Local government will offer cash award to eligible enterprises, in proportion to their annual business revenue; and enterprises with extraordinary economic contribution are allowed to apply for an extra incentive.
- (2) Local government will offer special funding support to the settlement of major projects involving emerging industries, or with high scientific and technological content and with huge development potentials. In addition, these enterprises are encouraged to settle in the Sino-Singapore Guangzhou Knowledge City in the first place and have prioritized access to apply funding support.

"1+7" 科技政策体系

The "1+7" favorable policies in promoting the scientific and technological development

2016年,为贯彻落实国家、省、市关于加快全面深化科技体制改革,加快创新驱动发展的相关政策要求,广州开发区、黄埔区全面实施创新驱动发展战略,加快推进建设创新驱动发展示范区、国际创新资源聚集区,发挥全区在广州建设国际创新枢纽主引擎、珠三角自主创新示范区核心区的作用,在原有的科技政策基础上进一步完善和创新,以《广州开发区、黄埔区关于加快建设创新驱动发展示范区、国际创新资源集聚区的决定》为统领,细化落实7个具体扶持政策,形成了"1+7"科技政策体系。

In 2016, in order to implement the overall strategies set up by Chinese central government, Guangdong provincial government and Guangzhou municipal government in deepening the scientific and technological institutional reform and speeding up innovation-driven development, Guangzhou Development District and Huangpu District launched a full-scale implementation scheme for the innovation-driven development. Efforts will be made to build an innovation-driven exemplary zone and an aggregation zone of international innovation resources, thus giving full play to the role of Guangzhou Development District and Huangpu District in turning Guangzhou into a major engine for international innovation hub and the core zone of PRD independent innovation exemplary zone. Based on the existing policy framework to support the scientific and technological development and guided by the decision made by Guangzhou Development District and Huangpu District in accelerating the development of an innovation-driven demonstration zone and an aggregation zone of international innovation resources, a "1+7" favorable policy system is finalized.

重大科技创新和成果转化

Major scientific and technological innovation and achievements transformation

经管委会、区政府批准的重大科技创新和成果转化项目,通过股权投资、贷款贴息等方式给予最高1亿元资金支持。

For any major scientific and technological innovation and achievements transformation project that has been recognized by the administrative committee of GDD and Huangpu district government, local government will offer financial support up to 100 million yuan in the forms of equity investment and discount government loan.

科技项目配套支持

Supportive measures towards scientific and technological project

- (1) 对获得国家、省、市科技部门立项资助的各类科技项目采用后补助的方式予以配套。对国家级科技项目,给予100%的资金配套,最高500万元;对省级科技项目,给予70%的资金配套,最高300万元;对市级科技项目,给予50%的资金配套,最高100万元。
 - (2) 对区内企事业单位参与管委会、区政府重点推进的国际科技合作计划的,经批准立项,采用后补助的方式予以不超过200万元的资助。
- (1) Local government will provide financial support to various scientific and technological projects that have been endorsed by Chinese central government, Guangdong provincial government and Guangzhou municipal government. For the state-level scientific and technological project, local government will offer 100% financial support, up to 5 million yuan; for the provincial-level scientific and technological project, local government will offer 70% financial support, up to 3 million yuan; for the municipal-level scientific and technological project, local government will offer 50% financial support, up to 1 million yuan.
- (2) For enterprises within GDD participating in international scientific and technological cooperation key projects in GDD, local government will offer these enterprises with financial support, no more than 2 million yuan.

研发机构及研发经费后补助

Funding support to R&D institutes

- (1) 经国家科技部门单独或联合认定的国家工程技术研究中心、国家工程研究中心、国家工程实验室等研发机构、给予300万元资助。
- (2) 经认定的省级研发机构,按省级科技项目配套标准予以资助。
- (3) 企业研发费用按《广州市企业研发费用投入后补助实施方案》(穗科信〔2014〕 2号)等有关规定执行。
- (1) Financial support, up to 3 million yuan, will be given to state-level engineering technology research center, state-level engineering research center, state-level engineering research center, state-level key lab among others, provided that the credentials of these R&D institutes have been recognized solely or jointly by state-level scientific and technological authorities.
 - (2) Local government will offer financial support to certified provincial-level R&D institutes in line with relevant standard.
- (3) The standard of the funding support to R&D institutes will be in line with the implementation scheme on subsidizing Guangzhou enterprises in carrying out R&D activities (Guangzhou science and technology, 2014, no.2) and other relevant guidelines.

奖励 Incentives

- (1) 获得药物临床研究批件的、给予10-50万元一次性奖励。
- (2) 获得新药证书的, 给予50-200万元一次性奖励。
- (3) 同时获得医疗器械产品注册证书和发明专利证书的、给予10-50万元一次性奖励。
- (4) 获得上级科技部门、知识产权部门奖励的、按区科技项目配套标准给予配套奖励。
- (1) A research institute that has obtained approval to carry out clinical study of drugs will be provided with a one-off cash award between 100,000 and 500,000 yuan.
- (2) A research institute that has obtained a new drug certificate will be provided with a one-off cash award between 500,000 yuan and 2 million yuan.
- (3) A research institute that has obtained a medical equipment product registration certificate and an invention patent will be provided with a one-off cash award between 100,000 yuan and 500,000 yuan.
- (4) A research institute that has been incentivized by an upper-level scientific and technological department or IPR authorities, local government will provide follow-up financial support in line with relevant district-level standard.

高新技术企业培育

Cultivation of high-tech enterprises

按照《广州市科技创新小巨人企业及高新技术企业培育行动方案》(穗府办函〔2015〕127号)等有关规定执行。

Cultivation of high-tech enterprises will be carried out in line with requirements as stipulated in the cultivation action plan of scientific and technological innovation little giants and high-tech enterprises in Guangzhou and other guideline.



8 supportive measures towards gazelle enterprises

- (1) 支持企业加大研发投入。按本年认定的研发费用总额的20%给予额外奖励,最高50万元。
- (2) 企业提供综合融资支持。给予认定当年5%一次性贷款贴息、单次最高50万元。
- (3) 加大企业融资补贴力度。给予企业获得投资额的10%的补贴,最高50万元。对于瞪羚企业投资引进的企业,给予投资额10%补贴,最高50万元,单个瞪羚企业200万元封顶。

- (5) Local government will offer various support to local enterprises in expanding their business scale; for example, prioritized land use will be offered to those enterprises each with annual business revenue surpassing 200 million yuan and accumulated tax contribution exceeding 10 million yuan a year.
- (6) Local government will offer support in helping local enterprises attract the settlement of high-end talents and urgently needed talents, in the forms of pay subsidy, hukou registration and schooling opportunities for the children of senior executives.
- (7) Local government will take active measures in helping local enterprises improve IPR invention, application, protection and management level. Funding support related to PCT international patent application will be extended to 6 countries in three years. In addition, local government will help cover 50% of the IPR investigation cost and litigation cost, up to 100,000 years.
 - (8) Local government will encourage various organizations in providing adequate services to local enterprises.

In order to implement the overall strategies set up by Chinese central government, Guangdong provincial government and Guangzhou municipal government in deepening the innovation-driven development and promoting the mass entrepreneurship and innovation, as well as with the requirement in building Guangzhou into a core zone for the state-level independent innovation exemplary zone and a high-level overseas talents innovative entrepreneurial base in China, GDD and Huangpu District have launched a full-scale talent policy system featuring the optimization of talent stock, increment of talent and talent quality improvement. Efforts will be made to improve the talent work mechanism, including talent introduction, cultivation, appraisal, and incentive and talent service. In addition, GDD has made outstanding progress in terms of talent flow, international cooperation, professional title evaluation, stock ownership incentive, achievement transformation, platform building, venture capital investment and financial support. The goal is to provide solid talent support in turning Guangzhou into an innovation-driven exemplar zone and an aggregation zone of international innovative resources.

- (1) Home purchase subsidy: a one-off subsidy no more than 300,000 yuan after tax; and the upper limit will be raised to 1 million yuan after tax, provided that the accumulated business revenue of the start-up exceeds 50 million yuan within 3 years.
 - (2) Rental subsidy: a subsidy enough to cover rent for a 150-square-meter apartment will be provided, for 3 years.
 - (3) Transportation subsidy: up to 2,000 yuan per month for 3 years.
 - (4) Academic exchange subsidy: up to 40,000 yuan a year for 5 years.
- (5) Setting-in allowance: a one-off subsidy of 20,000 yuan; if immediate family members of the high-end talents have their hukou registered in GDD, local government will offer them the same setting-in allowance of 10,000 yuan per person.
 - (6) Entrepreneurial training subsidy: up to 20,000 yuan for 3 years.
 - (7) Entrepreneurial assistance subsidy: provided with service coupons for 3 years.
 - (8) Cultural and sport related activities: these talents are allowed to use designated sport venues or fitness facilities free of charge.
- (9) Health care service: these talents will be able to access health care service which is equivalent to the standard for civil servants or employees within government agencies for 5 years; and a free health check will be provided once a year, and medical professionals will closely monitor the health condition of these talents.
- (10) Employment service for family members of these talents: local government will offer adequate support to help the spouses and their accompanying children of these high-end talents to get employed, and will designate local human resource and social security department to offer all the necessary assistance; for those spouses who are unable to find a suitable job at the time being, local government will offer them with living allowance, about 2,000 yuan a month for 1 year.
 - (11) Schooling opportunity for their children: local government will offer all the necessary support to help their children to attend school.
- (12) Fast-tracked domestic service: local government will offer green channel for these high-end talents, enabling them to access fast-tracked domestic services, in terms of housing, medical care, education, leisure and shopping; addition, high-end talents holding a foreign passport will be able to access administrative convenience for entry & exit and temporary residence in China.
 - (13) Entrepreneurial atmosphere creation: the subsidy is no more than 20,000 yuan a year.

- (2) Local government encourages investment-oriented talent retention. Angel investment institutions or individuals will be offered with one-off entrepreneurial financial support, which is about 50% of their investment volume and no more than 500,000 yuan, provided that their shares are no less than 10% or their investment volume is more than 500,000 yuan; and the upper limit will be further raised to 1.5 million yuan, if the angel investors are classified as high-end talents.
- (3) Local government values highly of knowledge-driven talent introduction. Universities or research institutes will be offered one-off entrepreneurial financial support, with amount no more than 50% of their contributed capital and no more than 300,000 yuan, provided that their shares are no less than 10%; if the concerned talents classified as high-end talents, the upper limit will be further raised to 500,000 yuan.
 - (4) Local government will provide these talents with free office space, with a size of no more than 300 square meters for three years.

- (2) An eligible outstanding senior managerial talent will be entitled to claim a cash award, which is equal to 30% of his or her taxable wages and salaries in previous year and no more than 1 million yuan after tax.
- (3) Local government will set up a senior manager award to honor those with the most outstanding growth, and each industrial enterprise above designated scale will be entitled for the award, exclusively for its chairman or general manager and one person for each enterprise, and the prize money is 50,000 yuan after tax.

- (3) 晋升资助和奖励:取得技师职业资格证书、且工作岗位与证书工种相匹配的,一次性奖励2000元;取得高级技师职业资格证书、且工作岗位与证书工种相匹配的,一次性奖励4000元。
- (4) 评优资助和奖励: 每年评选不超过1000名优秀高技能人才,给予每人每月500元住房补贴,补贴期限为1年。每年技能大赛奖励总金额最高20万元,给予上级评优的等额配套一次性奖励。
- (1) Talent introduction and incentive: local government will offer incentive to university-enterprise cooperation platform involving a local enterprise, with the amount no more than 100,000 yuan each time; and the university-enterprise cooperation involving website operation will be incentivized 100,000 yuan each year. These platforms will be awarded 100 yuan for every primary-level technician to be employed in GDD, and the amount will be raised to 300 yuan, 500 yuan, 1,000 yuan and 2,000 yuan for an intermediate level technician, an advanced level technician, an engineer and a senior engineer respectively.
- (2) Incentive towards talent training: each training center will be provided with a one-off construction subsidy of 100,000 yuan, as well as 50,000 yuan for its daily operation. Local government will offer subsidy up to 100,000 yuan to each master workshop for the use of technological research; in addition, local students, especially those with financial difficulty, attending district-level technician training school, or students from other regions where GDD offers poverty alleviation, will be offer a tuition fee allowance of 2,500 yuan a year; while the upper limit will be raised to 9,800 yuan a year for those underprivileged students, such as orphans, students from low-income family, and the accumulated amount for miscellaneous fees, accommodation cost, experiment fee and skill appraisal fee should be no more than 6,300 yuan, and the living allowance should not exceed 3,500 yuan a year. The subsidy standard for students from other regions where GDD offers poverty alleviation is 50% of the level for a local student with Huangpu hukou. In addition, training center providing order-based training activities will be offer subsidy, with amount equaling to 50% of a student's training cost.
- (3) Incentive towards technician level promotion: an individual, upon receiving a technician professional title and with his or her job post consistent with the same skillset as stipulated in his or her professional title, will be given one-off 2,000 yuan at a time.
- (4) Performance appraisal incentive: no more than 1,000 outstanding technicians will be selected each year, providing them with 500 yuan accommodation allowance a month for a year. The prize money for the annual skill competition is up to 200,000 yuan, and local government will offer the same cash prize to the competition winners, with amount equaling to the amount given by the upper-level governments.

- (1) Incentive towards a newly set up post-doctoral station (base): a one-off subsidy of 200,000 yuan; as well as a one-off subsidy to a newly set up post-doctoral innovation practical base.
 - (2) Incentive towards a post-doctoral innovation center: the center will be offered a one-off subsidy of 50,000 yuan if a post-doctoral is employed.
- (3) Incentive for the international cultivation of post-doctoral: a post-doctoral that graduates from a foreign university that is within top 200 universities worldwide will be awarded with a one-off subsidy of 50,000 yuan.
 - (4) Start-up capital for a scientific and technological research project: a one-off subsidy of 100,000 yuan.
 - (5) Living allowance: 100,000 yuan per person to be distributed in 2 years.
- (6) Setting-in allowance: a post-doctoral who signs a 3-year employment contract with a GDD-based enterprise upon his or her leaving from the Post-doctoral station in one year, will be given a one-off setting-in allowance of 150,000 yuan.
- (7) Post-doctoral research fund: a post-doctoral who succeeds in receiving funding support from state-level post-doctoral science fund will be awarded with a cash prize of 30,000 yuan; and the amount will be 10,000 yuan if the funding support application is accepted by state-level post-doctoral science fund.
 - (8) Up to 100,000 yuan will be offered to sponsor post-doctoral association in carrying out routine operation.

促进汽车产业发展暂行办法

The interim measure in speeding up the auto industry

◆ 奖励范围 Scope for the incentive

在广州开发区及其受托管理和下辖园区、黄埔区范围内办理工商和税务注册登记纳税、具备独立法人资格,实行独立核算,并上报统计数据的企业。本办法所称的汽车,特指乘用车。汽车制造业企业是指从事整车或发动机、变速箱等零部件研发、生产及加工的企业。

Passenger vehicle manufacturer with industrial & commercial formalities and taxation registered locally in GDD or business parks under its supervision, that operate in compliance with legal requirements and pay tax accordingly, are able to access these favorable policies; in addition, these enterprises must have an independent legal person status and conduct business accounting independently. Passenger vehicle manufacturer is classified as manufacturer of whole vehicle, engine, gear case and other auto parts.

- (3) To encourage vehicle related R&D: a passenger vehicle manufacturer can receive this special funding support, with amount equaling to 5% of the contractual amount of those purchased research equipment and no more than 1 million yuan for a same company each year.
- (4) To encourage the development of new energy vehicle: local government will offer discount government loan to passenger vehicle manufacturer undertaking new energy vehicle research, with subsidized interest amount equaling to 3% of the contractual loan amount and no more than 1 million yuan for each enterprise.
- (5) To encourage passenger vehicle manufacturers to improve production value: a passenger vehicle manufacturer with an annual output value increase of 5% will be entitled to receive funding support from local government, with amount equaling to 1‰ of the newly increased production value and no more than 2 million yuan for each enterprise.
- (6) To encourage the introduction of vehicle-related research projects: a passenger vehicle manufacturer with paid-in registered capital exceeding 20 million yuan will be entitled to receive funding support up to 3 million yuan.
- (7) To encourage the introduction of new energy vehicle projects: a passenger vehicle manufacturer with paid-in registered capital exceeding 50 million yuan will be entitled to receive funding support up to 3 million yuan.
- (8) To encourage the introduction of vehicle manufacturing project: a passenger vehicle manufacturer with paid-in registered capital exceeding 150 million yuan will be entitled to receive funding support up to 10 million yuan.
